## Financial Obligation

### Continuous Enrollment

All students are enrolled under a continuous enrollment contract. From the time the parent signs the contract, the student is enrolled at Harding through their 12th grade graduation or until the enrollment of the student is otherwise ended by the parent or the school.

### Contractual Financial Obligation

Harding Academy must make financial commitments on an annual basis to provide adequate faculty, staff, and other resources to educate its students. Because of those commitments, parents are obligated under the enrollment contract to pay the annual tuition charges for the entire school year unless the enrollment is canceled. The date of withdrawal will be effective the date written notice is received by the school or date sent, if sent via certified or registered mail. Tuition due for a student's canceled enrollment will be prorated according to the following schedule: 25% of tuition for withdrawals February 15–March 2025, 33% of tuition for withdrawals April–May 2025, 50% of tuition for withdrawals June–July 2025, 50% of unused tuition\* for withdrawals in August–December 2025, 75% of unused tuition\* for withdrawals in January–March 2026, and 100% of tuition if after March 2026.

\*Unused tuition means the prorated tuition based on the school days from date of separation to the end of the academic year.

## Payment Plans

### Due at Enrollment

**New Students**—The nonrefundable tuition deposit of \$900 per child and new student matriculation fee of \$150 are due with the Enrollment Form.

**Returning Students**—The nonrefundable tuition deposit of \$900 per child is due with the Enrollment Form.

### Payment Options

Harding uses the FACTS Management system for all student billing. For enrollment to be considered complete, FACTS Management billing sign-up must be complete.

**Prepay One Payment**—The annual payment is due June 5.

**Prepay Two Payments**—The two payments are due June 5 and July 5.

**Semester**—Semester payments are due June 5 and November 5. There is a \$15 handling charge per payment, per family for the semester payment option.

**Monthly**—Monthly payments will be drafted on the 5th or the 20th of the month depending on the selection indicated on the FACTS Management billing system. **Payments begin in June** and continue through May. Generally, the same amount will be drafted each month. There is a \$15 handling charge per month, per family for the monthly payment option.

### Incidental Charges

Extracurricular activities such as participation fees, class trips, and drop-in chargers may be billed on the FACTS Management system. Enrollment in camps and LEAP classes are paid for using the Active Network system. The cafeteria service is provided by Lexington Independents on a prepayment basis using the myschoolaccount.com system.
